Both the medication and the counseling are required pieces for MAT to be successful.

AxessPointe is one of the agencies that offer MAT in Portage County, including University Hospitals Portage Medical Center and Coleman Professional Services.

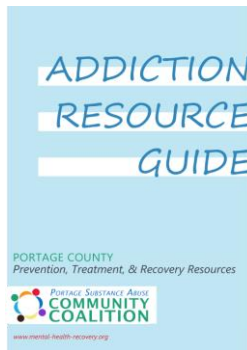

Townhall II earns Three-Year CARF Accreditation

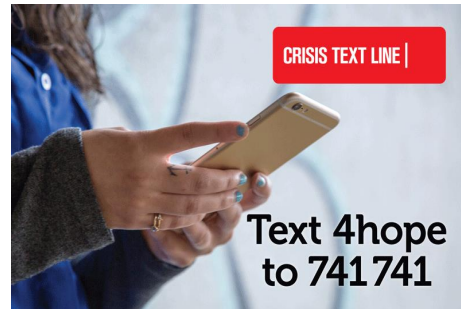
CARF International announced that Townhall II has been accredited for a period of three years for its Horizon House Women's Residential treatment program; Diversion/Intervention: Psychosocial Rehabilitation (children, adolescents, & adults); Intensive Outpatient Treatment: Alcohol & other Drugs/Addictions (adult); Outpatient Treatment: Alcohol & other Drugs/Addictions (children, adolescents, & adults); Outpatient Treatment: Mental Health (adults); and Prevention: Alcohol & other Drugs/Addictions (children & adolescents). The latest accreditation is the fifth consecutive Three-Year Accreditation that CARF has given to Townhall II.
